COSTS OF UNTREATED MENTAL ILLNESS IN INDIANA

In the US, approximately one in five individuals experience mental illness each year, yet less than half receive treatment.

The increased demand for services has outpaced the provision of care, leaving millions of people untreated or with unmet treatment needs:

- Approximately 429,407 Hoosiers had untreated mental illness in 2019
- Untreated mental illness was associated with \$4.2
 BILLION in annual societal costs in Indiana
 - \$3.3 billion in indirect costs
 - \$708.5 million in direct health care costs
 - \$185.4 million in nonhealth care costs

Untreated and undertreated mental illness is associated with profound long-term consequences, including reduced quality of life, productivity losses, worsening overall health, unemployment, and involvement with the criminal justice system.

These findings make the case for action and should be considered by policymakers, clinicians, and employers when allocating societal resources and funding to:

- Strengthen the mental health provider workforce
- Improve access to mental health services
- Ensure that policies enable providers to use the full range of treatment options
- Reduce barriers to treatment initiation such as transportation challenges
- Increase awareness and reduce stigma around mental illness
- Encourage employers to support mental health initiatives
